The 9<sup>th</sup> Annual California Beer and Wine Festival will take place on October 20<sup>th</sup>, 2018 at Yuba City's Town Center on Plumas Street. Tickets can be purchased in advance on the event website, [www.CaliforniaBeerAndWineFestival.com](http://www.CaliforniaBeerAndWineFestival.com), for \$30/person or on the day of the event for \$40/person. Each ticket provides attendees a souvenir tasting glass and loads of fun! Tastings are unlimited and last from 1pm to 5pm. Last year, 21 breweries and 15 wineries participated, pouring over 100 different varieties of beer and wine.

General admission to the street festival is free and provides attendees access to live music presented by local and talented musicians. Located throughout the area will be displays by local artists, vendors, restaurants, non-profits, and other community organizations. Each year, only 1500 tickets are sold but attendance is estimated closer to 3000 attendees because of the free entertainment provided.

Norris Family Charity, non-profit ID 27-0754257, organizes this annual fundraiser and distributes 100% of proceeds, requiring they stay in the Yuba/Sutter community. It is allocated throughout the community by way of a variety of deserving non-profits and charitable organizations. All donations are tax deductible.
